### News Letter 3/2010 March 2010

#### Dear Client

Due to late changes in the curriculum and due to the fact that the translation and proofreading of some Delta Education subjects take much longer than planned, we experience real difficulty in supplying some books in certain subjects on time.

We have been doing and are still doing our utmost to solve the problem as soon as possible. We know that the absence of the textbooks and parent guides in some subjects create put you, the parent or head of a support centre, in a precarious situation. March test series:	5%
June exam:	25%
September test series:	5%
November exam:	50%
Continuous tasks and projects:	15%
Grand total:	100%

By aborting the March test series, we shall change the mark allocation as follows:

June exam:	25%
September test series:	10%
November exam:	50%
Continuous tasks and projects:	15%
Grand total:	100%

2. We shall grant Delta clients a 10% discount on the price and shall amend the invoices accordingly. Clients due for credit shall receive their monies within one month of receiving the updated invoice.
3. We propose to host two congresses especially for our Delta clients. The first one in Pretoria for the clients in the Northern Provinces and the second one in Cape Town for our clients in that region.

**The purpose of the congress shall be:**

  - to discuss the future of Delta Education,
  - to deal with your questions and problems and
